#### **Powered Winch Discussion**

A discussion was held on powered winches and how they should be handled by NCPHRF. The committee came up with the following standards to determine what penalties, if any, should be assigned for a powered winch.

Halyard Winches: 0 sec/mi penalty (NCTR) Sheet winches, manually eased: -3 sec/mi Sheet winches, backwinding: -9 sec/mi

These penalties will be added to the Rules and Guidelines. The intent is that boats that are assigned a penalty for a powered winch should be sailing with non-powered boats as they have been penalized for their power, and do not need to be in a separate division, though organizing authorities can divide divisions however they want.

The following questions will be added to the PHRF Application:

Powered Halyard Winch: Y/N, Powered Sheet Winch: Y/N, Is powered Sheet Winch Backwinding: Y/N

The Rules & Guidelines will be updated with a powered winch section and a statement that if an organizing authority has not modified Rule 52 and a boat wants to race without their

powered winches, the rating can be adjusted by -3 or -9, depending on which type of winch is indicated on their PHRF certificate.
